The grant would be disbursed based on the following conditions:


1. The Centre must use the given funds for the proposed workshop only.
2. After completion of the workshop, the center must submit the Utilization Certificate (UTC) and specific head-wise bills of expenditures of the workshop to this office within 15 days.
3. After completion of every Crash Workshop, the Centre must submit the total number of students who participated, Overall Workshop Presentation, Lecture Presentations, and Overall Report & Photographs along with a CD of the workshop, both in soft form (e-form) as well as Physical (Hard) form within 15 days of completion of the workshop.
4. The Centre must submit the receipt of funds (Advance/First Stage/Remaining fund after submission of UTC) transferred through RTGS to this office within 15 days of the receipt of the funds.
5. The Centre must submit a list of participants (duly signed by the participants who have attended the workshop) to whom the registration Fees of Rs. 500/- or Rs. 1000 as the case may be; would be refunded at the end of the year.
6. The Centre must submit the Summary Sheet for Guest Lecturers/Resource Persons, Students Accommodated, Coordinator and Deputy Coordinator and Office Assistant duly signed by each BT-CBC Coordinator according to the format provided in the approved guidelines for N-BT-CBC.
7. The funds for the workshop completed as well as the advance budget for the next workshop will be awarded only after submission of all the necessary requirements mentioned above, by each cell within fifteen days of completion of the workshop.
8. As discussed in the Meeting of Network Coordinators of Capacity Building Cells, in the case where the number of attendees/participants is less than anticipated, this office shall allow payments (20% excess than those present, but not more than anticipated) as per actual presence from 3rd day onwards.
9. The submission of UTC and deliverables of every Crash Workshop must be as per the Formats and Checklist approved in the Guidelines (already provided) of N-BT-CBC.
10. All the decisions taken from time to time must be strictly followed by the center.

For the above-mentioned crash workshop, financial support of **Rs. 5,41,250/- [Rupees Five Lakhs Forty-One Thousand Two-Hundred Fifty only]** for the crash workshop has been approved for UG-BT-CBC. And an amount corresponding to **50% of the approved amount i.e., 2,70,625/- [Rupees Two Lakhs Seventy Thousand Six Hundred Twenty-Five only]** shall be disbursed to Pramukh Swami Science & HD Patel Arts College, Kadi to initiate the activities.

The final payment towards the workshop shall be released after submission of UTC and other deliverables from the center within 15 days of completion of the workshop subject to the conditions stated above.

The said expenditure will be debited from budget head – 01 'Development of Biotechnology' under Human Resource Development.

MEMORANDUM OF UNDERSTANDING (MOU)

This MEMORANDUM OF UNDERSTANDING (MOU) is made on 5th day of February, 2023 at Gandhinagar, Gujarat

BETWEEN

Higher Education Project Management Unit, situated at Commissionerate of Higher Education, 2nd Floor, Block No. 12, Dr. Jivraj Mehta Hospital, Sector - 10B Gandhinagar -382010, here after referred to as "**Higher Education PMU at CHE**" as First Party,

AND

"**Pramukh Swami Science And H.D.Patel Arts College**" Located at Kadi. Herein after referred to as "**Pramukh Swami Science And H.D.Patel Arts College, Kadi**" as Second Party,

Whereas,

- Higher Education PMU at CHE is a body for implementation of the **Student Start-up and Innovation Policy (SSIP 2.0)** in the higher education institutions under the CHE within the State of Gujarat.
- Pramukh Swami Science And H.D.Patel Arts College, Kadi** a recognised academic / technical / institute engaged in imparting knowledge in various disciplines through its establishment.

The Government of Gujarat under SSIP 2.0 had a vision to Empowering the young population of the State to unlock their creative potential through Start-up and Innovation to enable them to contribute for sustainable development and inclusive growth towards the realization of Aatma Nirbhar Gujarat.

For effective implementation of SSIP 2.0 and to achieve its goals and objectives the Higher Education PMU at CHE agrees for **conditional disbursement of grant to Pramukh Swami Science And H.D.Patel Arts College, Kadi wherein Pramukh Swami Science And H.D.Patel Arts College, Kadi agrees** to contribute under following:

1. Goals and Objectives of SSIP 2.0:

- Outreach and sensitize 5 million students for innovation and entrepreneurship, covering at least 1000 Higher Educational Institutions (HEIs) and 10,000 Schools of the State.
- Support to 10,000 student-led Proof-of-Concepts (PoCs/Prototype).
- Assistance to 5000 IP filings.



- d) Build capacity for at least 500 educational institutions and universities in the State, to have a robust pre-incubation support system for beneficiaries.
- e) Nurture 1000 school student led innovations.
- f) Groom 1500 student Start-ups and upscale existing Start-ups.
- g) Incubate 500 Start-up (physical and virtual).
- h) Support to 500 Start-up under Start-up Srujan Seed Support (Up to INR 10 Lac).

2. **Pramukh Swami Science And H.D.Patel Arts College, Kadi** agrees to pursue following interventions:

- a) Utilization of fund allocated to develop pre-incubation facilities and assist students in IP filing, developing PoCs, prototypes and other innovation related activities.
- b) Formation of committees to scrutinize and evaluate PoC/Prototype and IPR proposals.
- c) Systematic mechanism for creating awareness, outreach, and development of infrastructure.
- d) Selection of proposals for PoCs/Prototype and IPR.
- e) Ensure grant disbursements within 45-60 days.
- f) Ensure the entire PoC/Prototype/IPR grant be disbursed in maximum 2-3 instalments based on the progress.
- g) Implement and operate digital interface to create face-less and paperless mechanism for disbursement of grants.
- h) Strengthen mentorship programme with industrial expertise.
- i) Leverage other schemes and programmes at state and central level designed for Innovation and Start-up.
- j) Exposure and participation for flagship programmes at national and international level.
- k) Promote innovation and Start-ups by women, especially abled, marginalized community and those innovators trying to address persistent challenges of the State and the Nation.
- l) Any dropout from school / institute / university can avail the PoC/Prototype/IPR support by registering as the Policy beneficiary at educational institution level.
- m) Ensure the active participation of student beneficiaries in the PoC/Prototype/IPR for which the grant has been sanctioned.
- n) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** to support exposure to tinkering lab, Innovation Lab, Incubation Centres, large Scale sensitization, events, and programs for developing scientific mind set, collective/community level support system and activities and capacity building.
- o) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** to support to Maximum INR 2.50 lakh per PoC/ Prototype/ Innovation.
- p) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** to support 100% expenses of IP
- q) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** shall create IP facilitation cell (IPFC) under the guidance of State level IP facilitation cell at in-Hub.
- r) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** shall participate and comply with the state level interventions as given in Section 4.1.1 of SSIP 2.0 G.R. No. PRC/ 102021/ SSIP2.0/ 934/ S, dated 4th January 2022.



3. Terms and Conditions of the grant/funding:

- a) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** be provided a total financial support in the form of Grant-in-aid of Rs.500000. (Rupees Five Lakhs Only) for one year (2022-23), which would be exclusively spent on the specified purpose for which it has been sanctioned within the stipulated time.
- b) The grant-in-aid would be spent as per the approved action plan included in the MoU and mutually agreed to in consultation between Higher Education PMU and **Pramukh Swami Science And H.D.Patel Arts College, Kadi**.
- c) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** shall maintain a separate interest-bearing bank account for the funds to be disbursed by the Higher Education PMU at CHE. SSIP 2.0 grant will be credited by the Higher Education PMU at CHE to the concerned bank account. The interest earned on the grant money, would be reported to the Higher Education PMU at CHE and the same will be refunded to Higher Education PMU.
- d) The amount sanctioned during the first instalment will depend on the proposed and agreed expenditure as per the budget plan submitted by **Pramukh Swami Science And H.D.Patel Arts College, Kadi**.
- e) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** shall register itself with Controller General of Accounts (CGA) and the Comptroller & Auditor General of India (CAG) at its discretion shall have the right to access the books of account for the grant received from the Government under SSIP 2.0.
- f) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** will be required to submit Chartered Accountant certified Utilisation Certificates (UCs) with UDIN number of the grant at the end of each financial year as well as at the time of seeking further instalments of the grant, if any.
- g) Any unspent balance amount sanctioned by Higher Education PMU would be either adjusted towards the grants-in-aid payable during the next instalment or refunded to the Govt. of Gujarat by means of an Account's Payee Demand Draft drawn in favour of "Student Start-up and Innovation Policy" payable at Gujarat University, Ahmedabad.
- h) All the assets acquired or created out of the grant will be the property of the Govt. Of Gujarat and should not be disposed-off or encumbered or utilised for purpose other than those for which the grant has been sanctioned without the prior authorization from Higher Education PMU.
- i) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** agrees to comply with guidelines issued by the Higher Education PMU at CHE, Govt. of Gujarat from time to time for utilization of SSIP 2.0 Grant.
- j) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** abide to follow rules and regulation as mentioned in SSIP 2.0 G.R. No. PRC/ 102021/ SSIP2.0/ 934/ S, dated 4th January 2022 and Policy implementation Committee (PIC) or State-Level Apex Committee (SLAC) of SSIP2.0 in all circumstances.
- k) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** agrees to implement all the pedagogical and academic interventions as may be suggested from time to time by State Level Committee for SSIP 2.0 Gujarat.



- l) Student Innovation Fund proposed by **Pramukh Swami Science And H.D.Patel Arts College, Kadi** for subsequent four financial years from 2023-27 are subject to approval from PIC.

4. Obligations of Pramukh Swami Science And H.D.Patel Arts College, Kadi:

- a) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** agrees to accomplish proposed milestones as per its application for SSIP 2.0 grant; that are listed below:

- d) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** agrees to enter into an appropriate agreement with the inventor within framework of policy and guidelines given from time to time by the Higher Education PMU at CHE, Government of Gujarat.
- e) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** agrees to provide necessary support in promoting start-ups and innovation eco system in the institute.
- f) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** would provide the physical infrastructure/ civil work necessary for implementation of the above.
- g) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** agrees that no civil work / construction and similar activities will be carried out from the funds provided by the Higher Education PMU at CHE under SSIP 2.0.

5. Monitoring and Evaluation:

- a) The Higher Education PMU and the Operational PMU may review or / and scrutinize the fund utilized by the Grantees or Beneficiaries for the disbursed funds.
- b) The evaluation of performance of PMUs and Grantees would be done in agreement with implementation guidelines that will be released by the Higher Education PMU.
- c) A digital interface will seamlessly integrate all stakeholders to monitor each milestone in real time. Progress of key goals with respect to set KPIs will be publicly shared periodically.
- d) The Policy Implementation Committee (PIC) shall review overall policy objectives and its implementation.
- e) If a beneficiary is found unable to deliver the desired outcomes, further release of grant shall be reconsidered.
- f) The release of the grant after the first instalment and every subsequent instalment will be based on satisfactory implementation of the policy objectives.
- g) Expert Committee comprising of industry persons, ecosystem stakeholders, academicians, Start-up, nominated by the Technical Education PMU may visit Grantees periodically for ascertaining progress of work or resolving any difficulties if encountered for effective implementation of the Policy.
- h) A yearly impact report of the policy interventions will be published and shared with all stakeholders in public domain.



6. Termination of Support and Penalty:

- a) The Higher Education PMU, Government of Gujarat, reserves the right to terminate support to **Pramukh Swami Science And H.D.Patel Arts College, Kadi** at any stage under SSIP 2.0, if it is convinced that the grant is not being utilized properly or that appropriate progress to achieve objectives of SSIP 2.0 are not being made. The entire amount will be treated as a sunk investment and the assets acquired through the grant will be written-off by the Higher Education PMU at CHE.
- b) **Pramukh Swami Science And H.D.Patel Arts College, Kadi** agrees to repay/refund grant received under SSIP 2.0 with interest from the date of disbursement if the Higher Education PMU, Government of Gujarat is convinced that the grant is not being utilized for the purpose mandated by SSIP 2.0, the Technical Education PMU, and Government of Gujarat, reserves the right to recover any such amount.
- c) Higher Education PMU can recover any such amount through the revenue recovery process of the government.

7. Grievance redressal Mechanism

In case of any ambiguity or difficulty or query concerning interpretation and/or implementation of the Policy, the decision of Policy Implementation Committee (PIC) with the approval of the State-level Apex Committee (SLAC) shall be final and binding for all.

8. Validity of the MoU

The validity of the MoU starts from the date of signing till **the period of the Policy (March 31, 2027)**. The Higher Education PMU at CHE holds all rights to terminate the MoU if the educational institution fails to deliver its performance as per the action plan. This performance will be measured and monitored by the respective PMU. The MoU will be valid from the date of signing and it will be reviewed every year.
